2022/05/023 Finance Report- Audit - Accounts for 2021-22 have been circulated and the council have approved.

2022/05/025 Footpaths – Jubilee Trees requests from William Raby and James Long who have agreed to plant trees in the hedgerows and near to footpaths.

2022/05/026 Jubilee Picnic – a grant of £1,000 has been agreed and will be transferred to our bank account. Will need help from the Village Hall Committee. Chris and Andy have agreed to help. Propose to ask people who live in Washingly and some who have previously lived in the Parish of Lutton. Proposed by Carrie Walsh and seconded by Chris Cowdery.

2022/05/027 – Update on Hedge – Possible the work on the hedge will not take place until the Autumn. Lutton farm will provide a written quotation.
