# **Lutton Parish Council Biodiversity Policy**

## **Background**

In accordance with the duty imposed on town and parish councils by Section 40 Environment and Rural Communities Act 2006, updated by Section 102 of the Environmental Act 2021, Lutton Parish Council (hereinafter referred to as the council), which has any function excisable in relation to England must from time to time, consider what action the authority can properly take, consistently with the proper exercise of its function, to further the general by diversity objective.

This duty also means that town and parish councils can spend funds in conserving biodiversity.

### **Definition**

According to Defra (Biodiversity 2020), biodiversity, is the variety of all life on Earth. It includes all species of animals and plants, everything that is alive on our planet

## Aims and objectives.

The object of this policy is to work towards conserving, and enhancing the biodiversity of the council area.

The full council, and any committees of the council will consider the sustainability, environmental impact and biodiversity when making decisions and will develop and implement policies and strategies as required.

In particular, the Council will aim to improve the biodiversity in the area in the following ways:

Consider the potential impact on biodiversity represented by planning applications

Manage its land and property using environmentally friendly practices that will promote biodiversity

Support local businesses and council operations in the adoption of low impact/nature, positive practices

Encourage and support other organisations within the parish of Lutton to manage that areas of responsibility with biodiversity in mind

Support residence and local organisation activities to enhance and promote biodiversity

#### Actions

## Planning applications

#### The council will:

When commencing on planning applications, support site and building design that benefits biodiversity through the conservation and integration of existing habitats or provision of new habitats

Support protection of sensitive habitats from development and will consider whether the development would mean the loss of important habitats for wildlife and respect of ALL applications

Include policies in support of biodiversity within the neighbourhood plan.

## Land and property management

#### The council will:

Carry out a biodiversity audit of it's land holdings

Closer to the conservation and promotion of local body diversity with regard to the management of its open spaces. This will include adopting beneficial practices with regard to cutting and removing the vegetation, application of chemicals and timing of maintenance work, paying attention to the government's regulations for plant protection products.

Take special care in the specification of ground maintenance contracts to ensure that the work, whilst reaching acceptable standards, does not harm the natural environment

Consider biodiversity issues and the implementation of changes when managing its buildings.

# **Local Community**

#### The council will:

Raise public awareness of biodiversity issues, including through its website and newsletters.

Engage with local businesses and residents regarding biodiversity in the community, and how members of the community can assist and make a difference.

Where feasible, involve the community in biodiversity projects on its land, including for example, tree planting, wildflower meadows, bird box making.

### **Partners**

The council will work in partnership with other organisations to protect, promote and enhance file diversity within the council area.

It will review any local nature, recovery strategies, species conversation strategies, or protected sight, strategies in respect or local sites of specific scientific interest (SSSI's) and consider how it may become more involved in implementing the strategies' recommendations.

# **Monitoring**

This policy was adopted on 4th march 2024 (2024/03/016) and will be reviewed in two years, or sooner should the legislation dictate, at the annual meeting. A summary of how the policy has been implemented will be published annually, with reference to the original biodiversity audit and to show progress.
